Directions

Hormel Stadium

97 Locust Street, Medford, MA 02155 via Rt. 16 Mystic Valley Parkway, Medford

From North of Medford: Take Rt. 93 South to Exit 31 onto Rt. 16 East. Continue to traffic light (stay in left lane) and bear left. Proceed a short distance to the next traffic light (Hormel Complex and the Meadow Glen Mall are visible) and turn onto Locust Street. Turn left again in front of the Lumiere Apartments, Hormel Stadium and the parking lot is directly ahead.

From South of Medford: Take Rt 93 North to Exit 30 onto Mystic Avenue (Rt. 38), Somerville. Continue about 1.5 miles to Harvard Street intersection and turn right only Rt. 16 East. Proceed a short distance to the next traffic light (Hormel Complex and the Meadow Glen Mall are visible) and turn left onto Locust Street. Turn left again in front of the Lumiere Apartments, Hormel Stadium and the parking lot is directly ahead.

From East or West of Medford: Take Rt. 16 to Locust Street, Medford. Turn left in front of the Lumiere Apartments, Hormel Stadium and the parking lot is directly ahead.

Additional Information

Bus Parking:

Will be available in the front parking lot in front of the Andrews Middle School. Please drop off band students in the loop at the front of the school and park in the front lot.

Truck Parking:

Will be available in front of the McGlynn Middle School behind the Stadium.

Spectator Parking:

Will be available in the lot at Hormel when you enter from the Mystic Valley Parkway side. Additional Parking can be found across the street in the Meadow Glen Mall parking lot.

Restrooms:

Student restrooms will be available at the McGlynn Middle school. Hormel will also have bathrooms that will be open to the public.

Admission:

Admission as set by NESBA is \$10 for adults and \$8 for students. Children 5 and younger have free admission.
